

# BOODSKAP VAN DIE DIREKSIE VOORSITTER

In die eerste uitgawe van ons kwartaallikse nuusbrieff het Jeanny na ons Aftreelandgoed verwys as "ń eiland van uitnemendheid". Wat ń gepaste beskrywing is dit nie! Ek kan nog aan vele ander dink, soos bv. "Hemel op Aarde".

Die feit is dat ons besonder bevoorreg is om in so ń wonderlike plek te kan aftree. Natuurlik het ons almal baie hard gewerk en verdien ons dit om hier te kan wees. Ons eiendom is nie net ń woonplek nie, dit is ook ń duursame beleggingseiendom wat in waarde gaan toeneem.

Meeste van ons het egter reeds afgetree en ontvang nie meer ń maandelikse salaris nie en is afhanklik van ons pensioen en spaargeld. Gevolglik is dit van die uiterste belang dat ons WM op so ń wyse bestuur dat ons eiendom in waarde toeneem en die maandelikse heffings vanaf 2023 met minder as inflasie sal toeneem (ons koopooreenkomste bepaal dat 2022 se heffings met 8% sal toeneem om reserwes te bou soos wetlik voorgeskryf is). Om dit egter te kan doen sal ons nie net mooi na ons persoonlike eiendom moet omsien nie, maar ook na ons gemeenskaplike bates (leefstylsentrum, gimnasium, historiese gebou, dam, wandelroetes, meubels, ensovoorts). Die gemeenskaplike bates moet deur ons maandelikse heffings in stand gehou word en waar nodig vervang word.

Die huiseienaars het die Direksie en Bestuur ń mandaat gegee om WM namens ons te bestuur. Dit kan egter net gedoen word met die ondersteuning en samewerking van al die inwoners. Gevolglik pleit ek by u, kom ons vat hande en bou WM verder uit tot voordeel van ons almal. Laat al ons besluite in belang van WM geneem word en laat ons almal streng by die reëls van WM hou. Lees asseblief alle omsendskrywes wat aan ons gestuur word. Sluit ook aan by WM se amptelike selfoongroep sodat ons op hoogte van alles is wat hier plaasvind. Indien u enige probleme by WM ervaar, meld dit asseblief by die ontvangs aan waar dit gedokumenteer en nagespeur kan word.

WM is in ons hande. Ons besit ń juweel wat ons moet bewaar. Kom ons fokus op die positiewe en bou WM uit tot voordeel van ons almal.

## MESSAGE FROM THE BOARD CHAIRMAN

In the first edition of our newsletter Jeanny referred to our Retirement Estate as "an island of excellence". What an appropriate description this was! I can think of several others, such as "Heaven on Earth", for example.

The fact is that we are very privileged to retire at such a wonderful place. Of course, we all worked very hard and deserve to be able to do it here. Our property is not only a place to live, but also a durable investment property that will increase in value.

Most of us have already retired and no longer receive a monthly salary. We are dependent on our pensions and savings. It is therefore of the utmost importance that we manage WM in such a way that our property increases in value and the monthly

levies from 2023 onwards increase by less than inflation (our purchase contracts stipulate that our monthly levies will increase by 8% to build reserves as required by law). To do so, we shall not only have to look carefully after our personal possessions, but also after our common assets (lifestyle centre, gymnasium, historical building, dam, walks, furniture, etc.). These common assets must be maintained by our monthly levies and replaced when necessary.

The homeowners have given the Board and Management a mandate to manage WM on our behalf. This can, however, only be done with the support and cooperation of all residents. I therefore plead with you, let us take hands and develop WM further to the advantage of us all. Let us take all decisions in the interest of WM and let us all adhere strictly to the rules. Please read all circulars that are sent to us. Join the official WM cell phone group so that we can keep up with everything that takes place at WM. If you experience any problems, report them to reception where they are documented and can be traced.

WM is in our hands. Let us focus on the positive and develop WM for the personal advantage of us all.

# BIG BROTHER IS WATCHING

When first requested to write a legal article for The Marina News it was suggested that I write on the topical Protection of Personal Information Act (colloquially referred to as POPIA). I politely declined to write on POPIA, and decided to rather write on 2 acts which may in many respects seem to be the

antithesis of POPIA, i.e. the Promotion of Access to Information Act ("PAIA") and the Financial Intelligence Centre Act ("FICA"). I nevertheless for the context refer to POPIA below.

POPIA has the virtuous purpose to inter alia promote the protection of public and personal information processed by public and private bodies. However noble the objective might be I personally have grave reservations to what extent this legislation can in practice protect citizens' personal information in an age where Big Brother has for a protracted period been watching your every move and where you are constantly under internet surveillance. It is rather ironic that the State, which knows your every move, passed an Act to protect your personal information. As a further irony the IT-system of the Department of Justice (which administers POPIA) has recently been breached, potentially compromising your personal information held by the Department (e.g. by the Master of the High Court).

While POPIA seeks to promote privacy PAIA promotes freedom of information. PAIA's emphasis is on facilitating access to information rather than protecting privacy. PAIA is much "older" than POPIA, more interesting and more likely to be of help for ordinary citizens. PAIA intends to give effect to

the constitutional right to access to information that is held by the State (irrespective of whether the information is required for the exercise or protection of any right) and any information held by another person that is required for the exercise or protection of any right. PAIA applies to a record (i.e. recorded information) and not the information per se. Access is granted by submitting a request to the Information Officer / Head of a private body. Obviously, there are certain exceptions, but these fall outside the ambit of this article.

FICA introduces a framework that requires financial institutions and other businesses to take steps regarding inter alia client information. We all know the frustration of regularly having to provide documents in the process of being "FICAed", or as it is sometimes euphemistically called by the banks, "Know your Customer". Under FICA you need to provide your personal information and documents, which POPIA then seeks to protect!

In conclusion, and to complete the picture, it is necessary to also refer to the act with the overbearing name Regulation of Interception of Communications and Provision of Communication-related Information Act (colloquially known as "RICA"). RICA seeks to regulate the interception of certain communications. The unlawful interception of communications of certain private and public bodies by the Intelligence Services was recently in the news. This obviously frustrates the very purpose of RICA and POPIA.

All of the above regrettably reinforces Oscar Wilde's statement that "the study of law is sublime and its practice vulgar".

## SCAM WARNING

If anyone representing your bank telephones you to say you've been the victim of fraud and that immediate action by you will reverse the illegal transactions on your account - don't even continue the conversation. Rather phone the fraud division of your bank yourself. The scammers send proof of a couple of large unauthorised withdrawals and then reverse these once you have supplied your CCV number - but you have to supply the pin. NO bank will EVER request this information. The scamster is skilled at confusing you with a succession of smaller transactions which are reversed once you supply the pin, and you do not realise that the larger transactions have not been reversed and that you've given them the pin to clear out your account.

So the golden rule is: never supply a CCV or pin via phone, SMS, email, WhatsApp etc to ANYONE. Terminate the call and contact the fraud division of your bank immediately.


## A pleasant way to spend one's time here at WMRE

As birds are all around us, this pastime is an easy way in which to become involved with birdwatching and, in Southern Africa there is the possibility of seeing some 960 different species of birds. Our own "home grown South African" species, together with regular visitors from Africa and Europe, number some 840 birds with a further approximately 120 vagrants (only occasionally seen).


On our estate we have the potential of seeing about 100 species with some 40 to 50 species having already been seen. Different birds generally live in different areas and as birds are able to fly around easily, they are not (strictly) confined to these habitats.

Our lovely estate is in itself, a confining factor but as our gardens flourish, the growth of the shrubs and trees will in the future attract more birds. We are also fortunate in having our lake which entices additional species.

Vandat ons hulle gereeld voer, sien ek en Hettie ook gereeld groepe van bykans veertig Gewone Frette bymekaar in ons tuin. Kan iemand my vertel hoe kry hulle dit reg om almal saam soos "een Fret" op te vlieg as hulle elders heen wil gaan? Daar is nog baie dinge in ons natuur wat ons glad nie verstaan nie.

So drie weke later is die voerbak vol saad maar egter geen voëls nie? Wat gaan hier aan? Dis 'n oorlog in die klein en die skuldige een is die Koningrooibekkie (E: Pin-tailed Whydah) met sy wit pens so effens regs en hoër op in die boom in die tweede foto wat sy gekaapte koninkryk nogal agressief beskerm. Hy is die heel dag, letterlik elke paar minute, aan die wegjaag van toetreders en word skynbaar nooit moeg nie. Mag ons inmeng? Mens wil amper maar: "Nee, glad nie", dit gebeur in die broeitydperk by hierdie pragtige maar parmantige voël met sy baie lang stert, seker al vir millennia. Een van die dae is die broeitydperk verby en word hy maar weer 'n klein vaal voëltjie.

## Where do we go from here?

We as "birders" or "voëlkyners" can come together and create a "WM Birders Club"/"WM Voëlkynersklub" or also those of us who wish to become birders and this may include residents who are keen on bird



photography. Then, through this initiative we can start a Bird Sightings List for WMRE (Waldo's own list stands currently at 42 and Vincent's list at 49). And possibly form a WhatsApp group or rather, establish an e-mail contact where we can share exciting new sightings.

How do we get started: a good bird guide book and a pair of binoculars are the essentials. Other aids to birding would be:

- reading up on the subject
- attending a beginners course on birds
- viewing videos
- listening to bird-call tapes
- photographing birds which will also greatly assist in identifying a bird
- attracting birds into your garden

We are keen to know whether there would be sufficient support to establish a WM Estate Birding Group which would include photographers interested in birding who would be welcome, as a photographic record of our birds would be most valuable.

Between Waldo (Metallurgist) and Vincent (Optometrist), we believe we have the "metal" to form a birding group and the "vision" to see this task through to its finality. Jeanny Strauss, the WMRE General Manager, approached us concerning the project and fully supports this initiative.

maar dien nogsteeds as nie-uitvoerende direkteur van AVBOB asook op die direksies van twee ander maatskappye.



# A DIFFERENTLY ABLED RESIDENT

I would like to introduce myself to all readers as a new resident named Robbie van Eck. I was born with congenital deafness on 30 April 1956 from my Dutch immigrant parents residing in Braamfontein, Johannesburg. My four family members came ashore from the Dutch immigrant ship on 5 February

1954 in Cape Town. My father ran his chocolate business in Doornfontein, but he went into insolvency after embezzlement committed by his employee in 1959. My three family members and I have travelled to the Netherlands by ship along West Africa in 1958. I was diagnosed with chicken pox by the ship's doctor who forbade my whole family to go ashore there until I have recovered. My deaf brother looked after me in the darkened cabin. Then my family members and I were staying at my maternal grandmother in Amsterdam for six months. After returning home by plane my parents were divorced due to financial dispute.

On 7 April 1959 I was enrolled at Transoranje School for the Deaf in Pretoria West as a nursery school pupil just three weeks before I was 3 years old. I was going through all educational levels over 17 years and 8 months without being failed at a single school until 2 December 1976 when I matriculated with 2 distinctions in History HG and Accountancy HG. At the start and end of the school holidays I have travelled between Pretoria and Durban with Trans-Natal express trains. I have passed B.Com I in Accountancy at Unisa, but I have stopped my studies due to cataracts.

On 3 January 1977 I was appointed as an incoming returns clerk by now-defunct Volkskas Pretoria Branch with good work record straight from the start. I have had very good experience with outgoing remittances, clearances, bills and branch bookkeeping/Cash book. When Volkskas was merged with Absa in early stages in 1992 I accidentally knocked my pregnant colleague down the stairs due to poor lighting at the staircase, but very fortunately her unborn child was unharmed. The branch manager was furious at me and he was going to dismiss me for gross negligence and misconduct with intent to grievous bodily harm to my colleague, but the bank's CEO intervened. Then the branch manager was told not to dismiss me. My services there have honourably terminated with disability pension from Absa on 30 June 1993 for almost 26 years until 30 April 2019 when I was formally retired at the age of 63 years old. I am still receiving multiple annuities.

At the age of 22 years old I was diagnosed with retinitis pigmentosa in my both eyes. RP is an incurable hereditary retinal disease. In 1989 and 1990 I have undergone successful cataract operations with intra-ocular implants. Since then my vision is gradually deteriorating. My visual field and reading abilities are steadily diminishing, so I have to use my mobility cane with roller tip and assistive devices for reading. I am taking special eye vitamins to prolong my vision by 10 years. In 1987 the late professor in Ophthalmology told to me that I will go blind as my age is progressing in the later years ahead. I am also suffering from Usher's syndrome leading to deafblindness. My larger laptop/computer has been set in High Contrast with black background and larger text size to make reading easier.

In August and September 1995 I have travelled through Western Europe by bus, cross-channel hovercraft and express trains for 7 000 km. I have visited former Communist East Germany and East Berlin as some remnants of Communism were still visible such as foul-smelling and poor quality Trabant and Wartburg cars as well as Barkas minibuses that were rarely seen in the streets, but most of the infamous Berlin Wall has been already gone. I was staying at a hotel closer to Vondelpark in Amsterdam for a week and visited museums and took the canal boat trip. Its central part is still basically the same since 1958. I visited my Dutch family members who received me very warmly. My European trip has gone very well in spite of two near-accidents with a car and a tram in Amsterdam. From late September to early October 2001 I was in Auckland, New Zealand for attendance at an international Helen Keller Conference for the Deafblind. I have stayed at a suburban house overlooking the bay for 4 days and at a sheep, pig and cattle farm for three weekend days. On one Saturday afternoon at the farm I have participated with shooting practice with a bolt-action rifle with target of 25 metres with good shots in spite of my poor vision.

My own family members have passed away between May 1974 and March 2018 in Durban due to natural causes. My late deaf brother has the same hereditary condition. He was medically boarded from his job in 1991 after falling in the concrete moat and seriously injuring his leg at the hospital where he was receiving treatment for severe migraine. He went deafblind in July 2012 after his non-invasive brain surgery to have tumour removed from behind his right eye. He was at the same school along with me until December 1966 with Std.8(Grade 10).

I have worked at the non-profit organisations for the deaf and deaf aged between 1997 and 2016 as bookkeeper with clean audits.

On 21 August 2021 I have moved in at Waterkloof Marina in good health and relative safety from COVID-19 after four years at Thembalami Care Centre operated by State-aided long-established non-profit organisation for the aged after being moved over from Colonel Rowland Home in Bedfordview after merger on 21 June 2017. At end of May 2021 I have approached my life-long friend to find a very decent residence for me. In late July 2021 I was restricted to my room until further notice after three residents positive with COVID-19 were indiscriminately placed in an isolation unit very closer to my room by the management there. I was badly angered by their actions as they have put my own life and health at a greater risk. I was not allowed to travel to Pretoria for finalisation of my new residency here, so I have to appoint my friend to do everything on my behalf in absentia with e-mail communications between me and WKM from my room where I was imprisoned there. At that time all three residents have succumbed to virus and these rooms and a passage have to be sterilised. Within a few weeks I have gradually adjusted through familiarisation training. I have managed to go through the common areas and facilities with the fullest potential. On Sunday afternoons I am walking on a long pathway along the dam and marina with relative safety. I am very happy to be here with relative freedom with staying safe without being on the streets outside. I can sit down at the restaurant downstairs with independence, so I can manage to move around with relative freedom. I am empowered as a deafblind person with vision remaining.

I would like to call on all readers to be aware of my unique multiple sensory disability. The United Nations Convention on Rights of Persons with Disabilities empowers all disabled persons with their rights and prohibits all forms of discrimination. I also would like to give the following safety tips to prevent accidents:-

1. Look out for me while moving around our facilities and public areas with my white mobility cane with roller cane tip moving sideways.
2. Keep clear of me while moving towards you in an opposite direction and move away from my path.
3. Give way for me when I move in front of you and look carefully at my white mobility cane otherwise you will get hurt if my cane's lower tip locks your feet and you will fall badly onto the surface.
4. Don't obstruct my path in front of you. Move backwards and then aside from me. It is my right of way.
5. When you are entering or leaving the elevator, please look carefully at me with my cane as I can't see you well. Stop and move aside from me.
6. I can't hear whether you want to speak to me.
7. Follow COVID-19 protocol by keeping safe social distancing from me.



- Critical Care Assist will claim from the patient's medical aid for the ambulance and transport of the patient. Documentation and claims submission will be handled on behalf of residents for CCA services.
- The patient (resident) will be held liable for the account in cases where there is no medical aid. Residents are not obliged to make use of the CCA services.

## DELICIOUS CHICKEN PIE

RECIPE / RESEP • By Gi-Gi Robbertze



### Ingredients

- 1 Chicken
- Bouquet Garni (store bought / thyme, parsley, and bay leaves)
- 1 Carrot, roughly chopped
- 1 Onion, roughly chopped
- Salt and Pepper
- 3 Whole Cloves
- 3 Wonder Pepper corns
- 125ml dry white wine
- 3 tablespoons butter
- A grate of nutmeg
- 1 tablespoon Sago, soaked in a little cold water
- 2 egg yolks
- 1½ tablespoon lemon juice
- 1 egg, beaten with a little salt
- High rise puff pastry



### Method

- Brown the chicken with the onion and carrot (add salt and pepper)
- Cover with water and add the bouquet garni, cloves and wonder pepper
- Boil until the chicken is soft
- Debone the chicken
- Keep 125ml of the liquid (freeze the rest or use it for a soup)
- Boil the deboned chicken, 125ml liquid, white wine, butter, sago and a grate of nutmeg until the sago is transparent
- Beat the egg yolks with the lemon juice and add to the chicken mixture
- Lower the temperature and boil until the sauce thickens and is hot throughout
- Cover with pastry and bake at 180 degrees until golden brown
- Enjoy!
